The following is a matrix of sites within proposed The Journey Through Hallowed Ground National Heritage Area. To ensure accuracy, each site, its details and description, was sent to one of the three following organizations: the Pennsylvania Historical and Museum Commission, the Maryland Historical Trust and the Virginia Department of Historic Resources for analysis and updating. With the benefit of this insight, the details and description of each site was then re-evaluated and approved by the office of the Keeper of the National Register of Historic Places within the National Park Service. These steps will be taken with sites in West Virginia; Carroll and Washington counties in Maryland, and Spotsylvania county in Virginia for they have recently been added. The entire process took eight months through 2005 and was done to ensure the accuracy and integrity of this analysis.
